

## Bude 200 Years Ago in 1813

The following extract is from "Voyage Round Great Britain Vol 1" written by Richard Ayton in 1813 and published in 1814, six years before the first sod was cut on the Bude Canal. "This place is called Bude Haven, though at present only a sandy creek, where small vessels venture to ground, and are so exposed to the wind and sea, that they have a fair chance of having their bottoms knocked out by every returning tide. It was once a large and commodious port, all traces of which are now buried under the sand. The river Bude meets the sea here, and at its confluence formerly spread into a wide estuary, capable of receiving ships of great burden, but now runs to the sea in a shallow stream, navigable only for ducks and geese. The destruction of the haven is attributed both to the sand from the sea and the mud from the river: the first imbankment was of sand, which obstructed the mud in its passage to the sea, and co-operated with it in filling up the channel of the haven. But though Bude has at present no title to the character of a harbour, it is still frequented as a port, in consideration of what it was formerly, and greatly to the emoluments of the shipwrights. I saw several vessels moored on the sand, and was so struck with their evident exposure, that I could not forbear from expressing my opinion of their danger to some of the captains: but they all explained to me the cause of their situation by observing, and that too in a tone of justification, that Bude was once as good a harbour as any on the coast of Cornwall. I have never seen the game of follow-my-leader more desperately pursued. The village of Bude is very small but has some neat houses in it, which are let out as lodgings to visitors, who go thither for the benefit of sea-bathing, though the place is not supplied with any conveniences that can render the act of bathing either comfortable or decent, particularly to the ladies. No bathing machines are employed, and consequently the ladies are reduced to the necessity of undressing themselves in the dark and dismal caverns hollowed in the cliffs by the sea, and of parading into the water not unseen. At the precise moment which they choose for their dip, some male starers are certain to be picking up shells at the water's edge, who, under this pretence, have an opportunity of seeing the whole exhibition. There is no circulating library or trinket shop at Bude, where the visitors can spend their money and their mornings, so that, in spite of the bracing effects of the cold bath, I think I discovered some symptons of flaccidity about them, and a certain anxiety in their countenances which declared that they were seeking more than they could find. I have heard some seamen say that they preferred a storm to a calm, and I confess that beating hemp would be more to my taste than waiting three and twenty hours every day for a plunge in the sea. (An earlier "Tub Boat" gave an account by a lady of the difficulties of bathing towards the end of the 19th century, and another describing ships unloading at the Strand by Grenville's cottage in the 17th century but it was not clear that Bude was a "large port".) ## Lower Basin, Bude

On 17th October 2013, a meeting between Cornwall Council, Councillors, Officers and users and interested parties took place at Bude, to discuss the issues relating to the use of the Lower Basin. A full and frank exchange of the recent problems and suggested

solutions took place. After further discussion, it was agreed that from 2014 all use of the whole in water canal by commercial activity providers would be dealt with through the Environment Service's local Ranger Gareth Cann. Where necessary, he would liaise with the Harbour Master, Mr Paul Vincent. In addition extra signage will be provided to advise all users that they need to be licensed. Spot check to be carried out to reinforce the policy of licensed usage, both early and late in the day. The code of conduct will be extended to cover the Lower Basin. Each year, before and after the 'season', this subject will be addressed at the meetings of Bude Valley Management Advisory Group.

Also, at this meeting, it was reported that the problem affecting the use of the Sea Lock had been resolved, following an inspection by divers. The leak through the cill had been caused by metal debris. The cill was not damaged and the Sea Lock is now operational. The gate paddles are due to be serviced before the year end.

This was a useful and productive meeting showing the value of proper communication between all parties. Indeed a lesson for all. BCHS are grateful for the support from the Community Network Panel for Bude, Councillor David Parsons and Guy Pessell, Hon, Secretary Bude Canal Angling Association in bringing this matter forward for a proper discussion which should have resolved this matter.

## Barge Workshop, Helebridge

The work on the replacement roof should be carried out this winter, by the Bude Stratton Town Council;.

The Heritage and Culture Committee has indicated that they wish to make better use of the premises as a venue to give interpretation to the collection of artefacts kept in the premises including the Tub Boat. It is hoped to have a project for 2015/16 which would seek funding for HLF to achieve this object and improve access to the site.

With relation to old timbers stored at the premises the result of the dating examinations was inconclusive. However, the Heritage and Culture Committee have agreed to explore the possibility of carbon dating subject to costs. In addition, expert opinion is being sought as to what the timbers are reasonably considered to be.

This would allow the timbers to be displayed, probably at the Barge Workshop with appropriate interpretation as to their likely purpose and also the families involved in the late 16th Century.

## **Bude Canal Trust Report**

August/September

For those that have ventured along the Dunsdon section of the aqueduct they will have found the 300yd Dunsdon Reserve section having been dredged out and the sluice gates completed, has now been partially re-watered to test for leaks. One leak which caused a large hole to appear in the footpath was kindly repaired by the contractor on site but there are a couple of other small leaks on the footpath side which will need to kept an eye on to ensure a similar situation doesn't occur there.

The stonework and wooden rails of Gainsmoor Bridge have been rebuilt and repaired where needed. The original 3' dia. stoned culvert at the northern end of this section has unfortunately partially collapsed and silted up. This was backed up sometime in the past with a 12" concrete pipe. The heavy rain experienced last winter found this pipe to be inadequate and ditching work has now been agreed between all parties to cope with any repeated weather conditions.

Vealand bridge reconstruction has now been completed as far as materials have allowed, three capping stones are unfortunately still unaccounted for. Excavation of the immediate canal section either side of the bridge would bring about the final touches as and when finances allow.

October / November & December.

There have been the regular weekly work days (now switched to Wednesday) keeping the footpath, hedgeline and canal profile vegetation trimmed back. This work has concentrated on the sections between Virworthy Wharf and Cape Horn, Dunsdon Nature Reserve and the Holsworthy Branch although the whole length from the Lower Tamar Lake and the aqueduct bridge over the River Tamar is accessible.

Some mesh has been provided from the Devon footpath team to cover the surface of the small footbridge where it has been found to be quite slippery when wet.

The ever present leaks adjacent to the sluice at Virworthy wharf have highlighted the problem of creating a permanent seal between concrete structures and the clay lining to the canal profile. The Trust is extremely grateful to the Devon footpath team for the assistance of the two outside workers providing the excavation work and backfilling of the eroded channels undermining the footpath plus some high quality clay to rebuild the canal profile.

The committee would like to express their thanks and appreciation to all the members of the BCT Partnership, local businesses and

volunteers for the financial assistance received, donations of materials and physical on site hard work without which we would not have been able to achieve any of the targets we have done during the last twelve months.

#### Canal Cottage, Chilsworthy, Nr Holsworthy

During 2011, BCHS had some conversations and correspondence with the then owners of the above premises, Roy and Carol Smeeth, about the premises and its connections with the Bude Canal. Mr Smeeth sent BCHS some historical information about the premises and its occupants in the 1840's. Briefly, in the 1841 census the occupants of two cottages were Mary Rodd and her 5 children and a Richard Ellis, both were believe to be involved in the

operation of the Bude Canal. Adjacent to the cottage/s is the canal which crosses the Chilsworthy Valley on an embankment and turns the canal through 90 degrees as it progresses towards the outskirts of Holsworthy. It is also possible that this was the site of stabling for horses used on the canal and for other haulage purposes.







As you know I have been transcribing text from records books about the Bude Canal held by Bude Stratton Town Council in the Archives they maintain. During the past several months I have noted the following items about this premises:

- 1. Taken from 'The Canal Book of Reference re waste lands 1840-1841'
- 2. Taken from 'Bude Canal Works Information 1830-1843'

Both are hand written accounts of land or the working of the canal including tolls, wages, tonnage and stoppages.

In (1) above is recorded the following for plot 47 and 48. Plot 47 an area of land in the Chilsworthy Valley and rented by Richard Ellis at 15 shillings per annum.

Plot 48 – at the western end of the valley is a cottage built by the Canal Company for one of 3 labourers (Ellis), let at a rent of £3 per annum.

In (2) above, in the records of wages paid during 1840 commencing in June, are entries for labour which relate to the construction of this premises. In June it is shown a 'House at Chilsworthy - £1.5s 0d' and the following entries July to November 1840, it is shown as 'Ellis's House'. There are no other entries as to labour costs for this house and the total of wages for the six months was £26.12s.7d. There is no record of the cost of materials.

Nothing outstanding about this other than it relates to local persons living and working and probably having a better life with the canal than without.

#### View from the North


